INDEPENDENT ACCOUNTANTS' REPORT ON
APPLYING AGREED-UPON PROCEDURES

We have performed the agreed-upon procedures, which were agreed to by the management of the East Side Union High School District (the District) and the Citizen's Bond Oversight Committee of the East Side Union High School District (the Committee), to review expenditures of the 2008 Measure E General Obligation Bond Fund (the Fund), covering a minimum of 80% of the total Fund expenditures for the year ended June 30, 2009, for the purpose of verifying if the use of the funds is within the scope of the published election materials specifying the intended use of bond proceeds. We used the election documents and District resolutions as the guidance for the intended use of the bond proceeds. Management of the District and the Committee are responsible for the compliance with the election documents and District resolutions. This engagement to perform agreed-upon procedures was performed in accordance with attestation standards established by the American Institute of Certified Public Accountants and meets the compliance requirements to perform a "performance audit" as referred to in Proposition 39 and outlined in Subparagraph (C) of paragraph (3) of subdivision (b) of section 1 of Article XIII A of the California Constitution. The sufficiency of these procedures is solely the responsibility of those specified parties in this report. Consequently, we make no representation regarding the sufficiency of the procedures described below either for the purpose for which this report has been requested or for any other purpose.

Financial Summary

1. The 2008 Measure E General Obligation Bonds were authorized by an election of the registered voters of the East Side Union High School District held on February 5, 2008. The total amount authorized was \$349,000,000. The proceeds are to be used for the financing of site improvements and modernization of school facilities. The first series of bonds, Series A, in the amount of \$50,000,000 was sold on June 12, 2008.
2. Total expenditures for the year ended June 30, 2009, were \$22,383,034.

Agreed Upon Procedures Performed

1. Verify that the expenditures of funds were accounted for separately in the accounting records to allow for accountability.
2. Verify that the net proceeds from the sale of the 2008 Measure E General Obligation Bonds were deposited in total into the District's accounts by obtaining the settlement statement for the new bond issue and verifying that the amounts were appropriately deposited into the building and debt service funds, as required.
3. Test expenditures covering a minimum of 80% of the total capital project expenditures, exclusive of issuance costs and transfers out, and verify that the funds expended complied with the purpose that was specified to the registered voters of the District through election materials or District resolutions or the project priority list that was distributed to the voters.

Results of Procedures

1. The 2008 Measure E General Obligation Bond Fund expenditures were accounted for separately as Fund 23 in the Building Fund of the District.
2. All net funds received from the sale of the 2008 Measure E General Obligation Bonds were deposited in total into the District's accounts properly.
3. We examined expenditures aggregating \$21,570,587, which are 96% of the total Measure E Bond expenditures for the year ended June 30, 2009. Our review did not reveal any items that were paid from the Measure E Bond proceeds that did not comply with the intended use of bond proceeds approved by the voters of the District on February 5, 2008.

We were not engaged to and did not conduct an examination, the objective of which would be the expression of an opinion on compliance. Accordingly, we do not express such an opinion. Had we performed additional procedures, other matters might have come to our attention that would have been reported to you.
